B. Cobblestone Report

Property Management

Work on the stairway handrails is nearing completion. Collaborative Infrastructure Systems has managed working with two vendors to execute the structural work as well as the repair to handrails. Building F and G handrail repair is the top priority. Final column repairs should begin the week of April 14. Some emergency repairs were identified on the front set of stairs for the E Building that are planned to be addressed April 14.

Marketing and Leasing

As requested by the Board, three quotes for a monument sign at the Clower Street entrance were collected and distributed. Permitting will need to be completed with the City (to be led by Chair) prior to any fabrication and installation. Chair to coordinate with City staff on relevant requirements, including any use of City logo and potential for cost sharing.

Since the March meeting was canceled, opportunity for Board discussion was not provided last month. Discussions with Property Manager indicated a couple of members interested in purchase and one member interested in further discussion.
