2<sup>nd</sup> Reading -- ORD 2024-14 - An Ordinance to Adopt the Speed Zones Attached as Exhibit "A" Pursuant to Georgia Code, Title 40, Section 40-6-370 Through Section 40-6-376 and Section 40-6-181 Through 40-6-183 of that Title, The Uniform Rules of the Road; to Repeal Conflicting Ordinances; to Provide an Effective Date; and for Other Purposes

Mayor Bender explained that this is a process that has to be done every three (3) years so the City can renew its speed detection permit to allow the Police to run radar on City streets.

Council Member Schulz made a motion to approve ORD 2024-14, 2<sup>nd</sup> by Mayor Pro Tem Warner; voted 6 in favor and 0 opposed, motion approved. (A copy of ORD 2024-14 is attached to and made a part of these minutes.)

Consideration and Action on Award of Bid for the North Road and Wisteria Drive Project [Bender]

Mayor Bender explained that this bid is for the construction of intersection improvements, such as extended turn lanes, at North Road and Wisteria Drive.

Council Member Lenski made a motion to award the bid to Azimuth Contractors in the amount of \$2,036,325.56 pending approval of the contract by the City Attorney, 2<sup>nd</sup> by Mayor Pro Tem Warner; voted 6 in favor and 0 opposed, motion approved.

<u>Consideration and Action on RES 2024-15 – Abandonment of a Portion of Pine Street Right of</u> <u>Way [Bender]</u>

City Attorney Ross explained that during the rezoning request by First Baptist Church it was decided that there would be no connection to Pine Street for the proposed development so the property was deemed not to be useful to the City. The small stretch of property will be abandoned and deeded back to First Baptist Church.

#### ORDINANCE NO. 2024-14

AN ORDINANCE TO ADOPT THE SPEED ZONES ATTACHED AS EXHIBIT "A" PURSUANT TO GEORGIA CODE, TITLE 40, SECTION 40-6-370 THROUGH SECTION 40-6-376 AND SECTION 40-6-181 THOURGH 40-6-183 OF THAT TITLE, THE UNIFORM RULES OF THE ROAD; TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the governing authority of the City of Snellville, Georgia is the Mayor and Council thereof; and

WHEREAS, the governing authority of the City of Snellville, Georgia, desires to adopt the speed zones attached as Exhibit A; and

WHEREAS, the health, safety, and welfare of the citizens of Snellville, Georgia, will be positively impacted by the adoption of this Ordinance; therefore:

IT IS HEREBY ORDAINED BY THE GOVERNING AUTHORITY OF THE CITY OF SNELLVILLE, GEORGIA, and by the authority thereof that the speed zones attached as Exhibit "A" are hereby established.

IT IS FURTHER ORDAINED that any person convicted of a violation of this ordinance shall be punished as provided by law.

All Ordinances and parts of Ordinances in conflict with this Ordinance are hereby repealed.

This Ordinance shall become effective when appropriate signs are erected.






